Re: Her, Cha CDCR No. BF7761 Court Docket No. 17FE020975, 20FE007394, 20FE020470

Inmate Her is a well-established violent felon and should not be paroled. The circumstances surrounding his current conviction and prior criminal record show he poses an unreasonable risk of violence to the community. Inmate Her continues to possess guns and drugs and has no regard for the law.

In Case No. 20FE020470, on December 23, 2020, Sacramento County Detectives were monitoring Inmate Her, a known parolee. Detectives set up surveillance on 7806 Loucreta Drive, which was Inmate Her's residence. Detectives observed Inmate Her arrive at the location in a 2012 black BMW. Detectives conducted an enforcement stop and detained Inmate Her. A parole search of the vehicle revealed a plastic bag containing methamphetamine, US currency, plastic baggies, and an operable digital scale. Detectives also searched the residence. Outside the residence, Detectives located a black AR-style rifle with 30-round magazine wedged into the fence adjacent to the front gate. Detectives obtained a search warrant for the home and located processed marijuana, apparent pay-owe sheets, ammunition, scales, packaging, high-capacity magazines for firearms, and paperwork for Cha Her.

In Case No. 20FE007394, on March 7, 2020, Sacramento County Sheriff's detectives conducted an enforcement stop of a green Ford Expedition. The driver and sole occupant was identified as Inmate Her. A parole search of Inmate Her revealed 2 grams of methamphetamine on his person. A parole search of the vehicle revealed two loaded magazines with 9 mm ammunition and several loose 9mm rounds. Inmate Her stated that the magazines and rounds of ammunition belonged to him.

In Case No. 17FE020975, officers conducted an enforcement stop of a Honda Civic. Inmate Her was identified as the driver and the passenger was identified as Candy Thao. A search of the vehicle revealed a loaded silver semi-automatic firearm, a meth pipe, and shaved keys. A search of Inmate Her's person revealed a checkbook in his left rear pants pocket. The checkbook was addressed to

Cynthia **1**. Officers contacted **1** who indicated she had recently been a victim of a residential burglary where her checkbook along with other valuable items were taken. **1** advised that she did not know who Cha Her was and he did not have permission to have her checkbook. Officers reviewed the report regarding the burglary and learned that witnesses described the suspect vehicle as being a Honda Civic and a male Asian adult as the person who walked to the victim's home. Officers executed a search warrant of Inmate Her's listed address and located a firearm in a bedroom.

Inmate Her's previous convictions and prior prison experience did nothing to change his violent and criminal behavior. Inmate Her was pending judgment and sentence in case 20FE007394 for a thirty-two months prison sentence when he picked up case 20FE020470, where he was found with firearms and drugs. He is a clear danger to public safety and should serve his entire sentence.

Inmate Her has a long and violent criminal history consisting of multiple prison commitments for guns, vehicle thefts, and drugs. Inmate Her's criminal history begins in 2001 where he was convicted of possessing a weapon, a felony. From 2002 to 2013, Inmate Her was convicted of six vehicle theft crimes, five of those being felonies. In those convictions, he received sentences of two-hundred and forty days, three years, three-hundred and thirty days, three years, four years and eight months, and three years. In 2015, Inmate Her was convicted of receiving a stolen vehicle where he received a four year sentence. In 2018, Inmate Her was convicted of being a Felon in Possession of a firearm and First-Degree Burglary where he was sentenced to two years state prison. In 2020, Inmate Her was convicted of possessing ammunition. Two years later, Inmate Her is convicted of having another firearm. From 2005 to 2022, Inmate Her was also convicted of four parole violations. Inmate Her is clear danger to society. He is a habitual offender whose crimes pose a great danger to society as they consist of firearm possession, vehicle thefts, and drugs. Inmate Her has only served ten months of his four-year prison sentence and should serve the remainder of it in custody.

As we are given 30 days to respond, and we are not provided with any recent disciplinary history or any other information aside from the one-page notice of parole review, I cannot comment on Inmate Her's prison conduct. However, from the record that is available it is clear that Inmate Her should not be released as he poses a significant, unreasonable risk of violence to the community. Parole should be denied.
