Inmate Julian Clark is a danger to the community and should not be paroled. The circumstances surrounding his current convictions and his prior criminal record show that he poses an unreasonable risk of violence to the community.

On August 7, 2019 at approximately 9:30am, Sacramento Sheriff's deputies received a call regarding a suspicious person "casing" a house on the corner of Power Inn Road and Lori Avenue in Sacramento County. They arrived at the location within approximately 8 minutes and saw the side gate to the residence open and the rear sliding glass door open. Deputies announced their presence and heard movement in the bedroom. They then observed Inmate Clark jump onto the bed and look at deputies. He jumped onto the windowsill and escaped through a front window of the home. Deputies shouted commands at Inmate Clark to stop but he continued to flee. They apprehended Clark as he tried to jump over a fence and deputies grabbed him. Deputies noticed Clark wearing socks over his hands to avoid fingerprint detection, and located jewelry on her person taken from the home. The victims stated that in total, Clark had taken approximately \$7,000 worth of items.

Inmate Clark's record includes numerous prior convictions for burglary-related crimes. He has three prior first degree burglary convictions in violation of PC 460(a). His first conviction was in 1992 out of Redwood City for a consequence of 4 years in State Prison. His second and third were both out of San Mateo County in 1999 for a total sentence of 15 years, 8 months in State Prison. Between those convictions, he was convicted in San Mateo county for possession of stolen property in violation of PC 496(a) and sentenced to 32 months in State Prison. Since 1992 until now, Inmate Clark has spent the majority of his years either in custody for theft related offenses or on parole for those offenses. It is clear that Inmate Clark has shown no remorse for his crimes and has no intention of stopping his criminality. The only way the community is safe from his criminal activity is if he is in custody.

As we are given 30 days to respond, and we are not provided with any disciplinary history or any other information aside from the one-page notice of parole review, I cannot

comment on Inmate Clark's prison conduct. From the record that is available it is clear that Inmate Clark should not be released as he poses a significant, unreasonable risk of violence to the community. Parole should be denied.
