Inmate Garcia is a well-established felon, and should not be paroled. The circumstances surrounding his current conviction and his prior criminal record show that he poses an unreasonable risk of danger to the community.

On September 3, 2017, inmate Garcia was observed by law enforcement driving a vehicle with expired tags. Inmate Garcia was on parole and a search of his vehicle revealed a loaded semi-automatic firearm with five rounds of ammunition hidden in the dashboard. The firearm was stolen. On inmate Garcia's cell phone were text messages from a female who was asking inmate Garcia if she could borrow his gun.

Inmate Garcia's criminal history began in 1988 when he was nineteen years old and convicted of PC 245(a)(2) for shooting a gun from a vehicle into another vehicle. Inmate Garcia has consistently committed crimes over the last thirty years. The only time he has gone more than a year without committing a crime is when he is in custody. In 1995, inmate Garcia was convicted of Stalking. Inmate Garcia had threatened to kill his ex-girlfriend with a gun and displayed a gun clip to the victim while stating, "this is for you and the kids."

In 2008, inmate Garcia was threatening his ex-wife with a knife in front of a Taco Bell. When officers arrived, inmate Garcia began to walk away. The female yelled that he had a knife. Inmate Garcia then threw a folding knife with a two and half-inch blade. While out on bail, inmate Garcia was driving a vehicle without a license plates or registration. A search of his vehicle revealed a 22-caliber handgun concealed in a first aid kit. He was again released on bail and was arrested a month later for a road rage incident where he threatened to kill the victim and began pounding on the victim's car with a knife. Inmate Garcia tried to open the door and pull the victim out of his car. He followed the victim back to his house and made additional threats to him. Inmate Garcia received a ten-year prison sentence for these offenses. Shortly after being released he was arrested for the current offense.

Inmate Garcia has consistently shown that he has a complete disregard for the law. At this point, he has proven that once he is released he will victimize society as soon as possible. He continues to illegally possess firearms and use narcotics. It is only a matter of time before he kills someone.

As we are given 30 days to respond, and we are not provided with any disciplinary history or any other information aside from the one page notice of parole review, I cannot comment on inmate Garcia's prison conduct. However, from the record that is available it is clear that inmate Garcia should not be released as he poses a significant, unreasonable risk of violence to the community. Parole should be denied.
