Inmate Hoang has been convicted of multiple felonies involving drug transportation and sales, firearms and pimping. The circumstances of his commitment offense and his criminal history show he poses an unreasonable risk of danger to the community. For these reasons and those that follow, he should not be paroled.

On August 26, 2016 at 3:00 a.m., officers attempted to make a traffic enforcement stop on the vehicle Hoang was driving because the registration was expired. Hoang failed to stop and instead accelerated to a speed exceeding 80 mph. He then evaded officers by entering eastbound Interstate 80 and continued to speed between 80 to 100 mph. Hoang eventually exited the freeway using an *onramp*, driving the wrong way on said ramp. When he traveled onto the surface street, he continued to evade officers and drove over 70 mph. Hoang then ran four stop signs, driving 70 mph on surface streets. He then increased his speed to over 100 mph and ran red stop lights at three major intersections. Hoang eventually lost control of the vehicle and struck a parked car. The vehicle he was driving came to a rest in the front yard of a residence. Hoang sustained a broken arm in the collision and evaded no further. Officers determined that Hoang was on parole and that he was driving a stolen vehicle. Officers searched Hoang and the vehicle and found the following: a stolen and loaded .45 caliber semi-automatic pistol, over three pounds of methamphetamine packaged in 12 separate bags, two grams of cocaine and twelve pills of hydrocodone. Hoang had \$3,777 cash on his person.

Regarding his criminal history: In 2005, Hoang was convicted of HS section 11377 (felony). Also in 2005, Hoang was convicted of PC section 496(a), VC section 10851(a) and HS section 11377 (all felonies) and sentenced to two years state prison. In 2007, Hoang was convicted of HS sections 11378 and 11379 and sentenced to four years state prison. Also in 2007, Hoang was sentenced to four years state prison after being convicted of VC section 10851 and PC 496(a). In 2009, Hoang was convicted of VC section 20001 and sentenced to 16 months state prison. In 2010, Hoang was convicted of PC section 266h and sentenced to 3 years state prison. In 2014, Hoang was convicted of VC section 23152(e) (misdemeanor) and felony 11377 (sentence unknown). In 2015, Hoang was convicted of HS section 11370.1(a) and sentenced to 3 years state prison.

Finally, regarding Hoang's prison behavior. Although he has not been convicted of any inprison offenses, he has not been completely blame-free. He has three times been found guilty of possessing a cell phone (January 2017, June 2017 and December 2018).

Inmate Hoang is not someone the Board should take a risk on by granting early parole, as he poses an unreasonable risk of danger to the community. Parole should be denied.
