In 2003 he suffered his first felony conviction for attempted grand theft in violation of Penal Code §§ 664/487 and received 360 days in jail. He was released from jail on 10/12/03. On 4/25/04, he was arrested for petty theft with prior thefts and his probation was granted and he was given additional jail time. He was released from jail on 7/1/04.

Three months later, on 10/9/04 and 10/14/04 he committed robberies. He was convicted of both of these violent strikes. After the latter robbery, he engaged in a dangerous high-speed pursuit with officers. He additionally was charged with a battery resulting in great bodily injury which occurred on 11/19/04, a serious felony charge which was eventually dismissed with a *Harvey* waiver when he plead to his two robbery convictions, which means the judge was able to consider the facts underlying that battery in arriving at the judgement on his robberies. He was arrested on 11/23/04 for that crime series and sentenced to state prison on 4/18/05.

I do not have access to his CDCR records so do not know when he was released on parole but he was next arrested in Sacramento county on 3/18/08 for a violation of Health & Safety code § 11350. It appears he was in custody on a parole violation until 4/21/08.

He was arrested twice in 2009 for parole violations and was last released from jail on 12/28/09. Two and a half months after his release, he was arrested on 2/17/10 for his next strike, a violation of Penal Code § 459 1<sup>st</sup> degree. He admitted to having suffered a prior strike and was sentenced to prison on 8/5/10.

It appears that he was released on parole on 3/30/13. On 10/1/13, while on parole, he was arrested for and convicted of petty theft and was sentenced to time on Sheriff's Work Project. On 12/27/13, he was arrested for petty theft with a prior theft conviction. He plead to that as a felony and was given one more opportunity to rehabilitate himself in the community after serving a 365 day jail sentence. He was released from jail on 8/6/14. He was on Sheriff's Work Project from 8/11/14 - 11/10/14 and then he served time in county jail again from 11/10/14-11/21/14.

On 2/25/15, a warrant was issued for probation violation. He was arrested for his current offense on 8/21/15 at which time he also had a PAL warrant for his arrest. He was found driving a moped which had recently been stolen where the suspect cut the padlock off of a chain link fence in order to steal the moped from the front yard. The moped had been painted black after it was stolen and there were several live rounds of ammunition found under the front seat storage area. The inmate also possessed a backpack

which contained bolt cutters. He admitted to having painted the moped black, but he denied stealing it. He also admitted that the ammunition was his.

In summary, Inmate Jackson has 6 fellow felony convictions [PC 664/487, 2 counts of PC 211, VC 2800.2, PC 459 1<sup>st</sup> and PC 30305] and 3 of them are strikes. He has never successfully completed probation or parole without the commission of a new felony offense.

At the time of his current offense, he was on one grant of misdemeanor probation, one grant of felony probation, parole, and he had warrants outstanding for his arrest for probation violations and parole violations. He was a convicted robber and thief who was driving a stolen vehicle while possessing ammunition for a firearm. One wonders why a convicted robber felt the need to violate probation and parole in order to possess ammunition...

Based upon Inmate Jackson's lengthy and violent criminal history and inability to conform to the requirements of probation or parole, the People request that his early release be denied as a non-violent second striker.
