Best Practice

The Family Justice Center (FJC) is a "Best Practices" model for domestic violence intervention. (U.S. Department of Justice.) The FJC brings trauma-informed services to you under one roof, sensitive to the trauma of those who have been victimized so they are less likely to have to repeat their story multiple times.

Frequently Asked Questions Who can get help at FJC?

FJC helps survivors of domestic violence, elder and child abuse, sexual assault, stalking and human trafficking.

Do I need an appointment?

No. Individuals requesting a restraining order or who need help with emergency safety planning, shelter, crisis counseling, assistance with prosecution, or other supportive services are seen on a first-come, first-serve basis.

For family law matters, individuals may be seen the same day depending on attorney availability. If an attorney is not available, you can schedule an appointment.

What should I bring?

You should bring legal documents including: existing restraining orders, child custody and visitation orders, and police reports.

Can I bring my children?

Yes, we have a designated area for children. Play care is sometimes available but we recommend that if you can, please bring another adult to watch your children while you receive services.

Is transportation available?

Yes, depending on availability. FJC can provide transportation for some FJC appointments and court hearings.

Do I need to bring an interpreter?

Many of FJC's staff members are bilingual. If needed, we will do our best to arrange an interpreter to assist you.
