**Re: Gibbons, Brandon CDC # BC9251 Court Docket: 17FE016387**


Inmate Gibbons—at only 31 years old—is already a multiple-time convicted felon, and should not be paroled. The circumstances surrounding his current conviction and his prior criminal record show that he poses an unreasonable risk to the community.

In the early morning hours of January 19, 2017, Inmate Gibbons and a codefendant were contacted by law enforcement during a traffic stop. Inside the vehicle, Detectives located a large amount of power tools and other stolen property. The power tools were marked “Property of Placer County.” Each tool was individually numbered, which led Detectives to the reporting party—██████ M██████ Mr. M██████ indicated that he parked his Placer County vehicle outside his home the night before. When he returned to his truck in the morning, the locked tool box had been broken into and numerous tools were missing. In a statement made to law enforcement, Inmate Gibbons indicated that while he was the driver of the suspect vehicle, the codefendant would break into and steal items from various pickup trucks.

Offenses of this type are not out of the ordinary for Inmate Gibbons. In total, Inmate Gibbons has received seven adult convictions. Of those seven total convictions, five are for theft-related offenses ranging from misdemeanor burglary, to a strike conviction for residential burglary. In Inmate Gibbon’s strike conviction, he was determined to have gone through a mobile home as the victim was out of town. Law enforcement learned that items within the residence had been disturbed, and a computer had been stolen. When latent fingerprints were discovered at the scene, they were tested, compared, and ultimately matched Inmate Gibbons. Worthy of note, is that Inmate Gibbon, not including the present offense, has been sentenced to three separate prison terms *after* his strike conviction, totaling approximately nine years.

As we are given 30 days to respond, and we are not provided with any disciplinary history or any other information aside from the one-page notice of parole review, I cannot comment on Inmate Gibbon’s prison conduct. It is clear from the record that is available that Inmate Gibbons should not be released as he poses a significant, unreasonable risk to the community. Parole should be denied.
