Board of Parole Members,

I write in opposition of the Parole Board releasing Brent Loring Hall CDC#J027425 early. Mr. Hall was sentenced under a plea bargain. This case involved a Felony Evasion and Vehicle Theft. Mr. Hall was a Parolee-At-Large at the time of this offense. During the offense, Officers were in contact with Parole Agent Dunne in an effort to locate the Defendant in a certain neighborhood. Sacramento Police Department Officers happened to locate Mr. Hall and attempted to pull the car he was driving over. Mr. Hall accelerated to speeds of 50 MPH in a 25 MPH zone as he approached W Street in downtown Sacramento. He ran stoplights and stop signs, all at 6 pm on a Saturday night. Mr. Hall then made his way to 16 Street-which is a notoriously busy thoroughfare, before entering onto Business 80 freeway. Once on the freeway, Mr. Hall reached speeds of 95 MPH. Mr. Hall made numerous evasive maneuvers to avoid capture and was trying to get the Officer to commit to getting off on various off-ramps, including s/b 99, 34th Street, and 59th Street, before weaving back through various lanes of traffic.

Once an SPD helicopter began following Mr. Hall, the SPD Officer was able to slow down and conduct more of surveillance type driving in following the car. Mr. Hall then abruptly stopped the car half way down the off-ramp of 65th Street and foot bailed down the embankment before climbing over a cyclone fence. An SPD K9 unit was dispatched to attempt to capture Mr. Hall, who was climbing over residential fences before finally hunkering down in the backyard of a residence. SPD eventually apprehended him in this backyard. The car that he was driving was stolen.

In terms of Mr. Hall's criminal history, his record is appalling:

If there was ever a Defendant more deserving of the sentence he received in his current case, it is Mr. Hall. How could we ever consider letting someone out of custody early who has demonstrated that he does not obey Officers, does not obey Parole, and has absolutely no concern for the welfare of the citizens of Sacramento as evidence by his driving? His behavior over the course of his life is horrendous and he should sit in custody for the full time that was contemplated by his plea bargain. When he does get out, we will, without a doubt, see Mr. Hall in our courts again.
