RE: Jardine, Dale #AU7643

Calling Inmate Jardine a "Non-Violent Second Striker" mischaracterizes his criminal history and his continued disregard for the laws of our society. To suggest that he is non-violent is, at best, laughable.

- 1990 – Taking a vehicle for temporary use and vandalism
- 1990 – Disturbing the peace
- 1990 – False identification to a police officer
- 1990 – Petty Theft
- 1991 – Disorderly conduct
- 1991 – Receiving stolen property
- 1991 – Possession of a dangerous weapon
- 1993 – Possession of a dangerous weapon
- 1997 – Battery on a non-cohabitating spouse
- 1999 – **Threatening a witness or victim of a crime**
- 2001 – Violation of Probation = sentenced 16 months state prison
- 2002 – Violation of Parole
- 2004 – Under the influence of a controlled substance
- 2005 – Residential burglary = 3 years state prison
- 2007 – Violation of Parole
- 2009 - Unlawfully causing a fire
- 2010 – Violation of Parole
- 2012 - Vehicle theft
- 2012 - Attempted theft
- 2013 – **Terrorist threats**
- 2013 – Violation of a criminal protective order
- 2014 – **Possession of a controlled substance while armed**

In 2013, this “non-violent” inmate got into an argument with this ex-girlfriend in front of her 9 year old niece. He left the movie theater to retrieve items from her car. He then returned a few minutes later and yelled, “Bitch, come open your car so I can get my shit out”. As she walked out to her car, he called her “bitch, slut, c[REDACTED] and white whore”. He then walked away. Approximately an hour later, he called her phone numerous times and sent her 15 – 20 threatening text messages. On one of the phone calls, he said that he was going to stab her. He left another message that said, “You are dead”. A pocket knife was located in the room where Inmate Jardine was staying. The Victim was terrified that Inmate Jardine would carry out his threats. After Inmate Jardine was placed in police custody, he called the Victim again from the jail and left her the following message: “I will come after your kids. I don’t give a f[REDACTED]. Don’t play with me”.

In 2014, officers received an anonymous complaint regarding drug activity at Inmate Jardine’s residence. Officer conducted a probation search of his home and located methamphetamine and a loaded .40 caliber semi-automatic handgun with a large capacity magazine on his nightstand in his bedroom. Officers also located a Winchester rifle in the gun safe in his bedroom. Inmate Jardine was convicted of his offense and was sentenced to 4 years in state prison.

It would defy logic and a sense of justice that Inmate Jardine, after displaying a lifelong lack of respect for the law, would be rewarded with a reduction of jail time. Clearly this inmate’s repeated failures to transition smoothly into a community and live as a productive member of that community indicate a high propensity for recidivism. He has not had a single successful probation or parole period [REDACTED] The Sacramento County District Attorney’s Office strongly believes that he is not an appropriate candidate for early parole. Inmate Jardine has demonstrated time and time again as seen in his multiple parole violations and convictions that he still poses a viable and unreasonable risk to public safety.
