In 2014, Inmate Kelley let his anger get the best of him once again. Separated from his wife, and hearing rumors that a neighbor was talking "bad" about him, Inmate Kelley decided to take matters into his own hands. He walked up to this neighbor in a parking lot and confronted him. When the victim tried to avoid him by riding away on his bike, Inmate Kelley grabbed his bike. Inmate Kelley was substantially bigger than his victim and also armed with a knife which he proceeded to use to slice his victim's face. Two college students in the parking lot caught the entire incident on video before others intervened to put Inmate Kelley in the back of their Pontiac. He sustained his first felony strike conviction for assault with a deadly weapon and was sent to prison.

Inmate Kelley began his criminal career sixteen years earlier in 1998 in Lake County when he was convicted of inflicting corporal injury on a spouse, and obstructing a peace officer as well as of theft. Two months later in Alameda County, he was convicted of false imprisonment. He was originally sentenced to forty-five days in jail for that offense, but eventually suffered 3 violations of probation for this offense, earning an additional 225 days in county jail.

In 2000, he sustained his first felony conviction of grand theft in Alameda County. By 2001 he was in Sacramento County, sustaining another conviction for obstructing a peace officer. Less than one month after that conviction, he was convicted of possession of a hypodermic needle.

By 2005 he was back in Alameda County where he sustained another misdemeanor drug conviction. Then, in 2006, he was convicted of a deadly felony: violation of Penal Code § 273a(a), child cruelty or endangerment under circumstances likely to cause great bodily harm or death. Since the crime was not in Sacramento County, we do not have easy access to the underlying offense reports. He was eventually committed to State Prison however, so hopefully CDCR records contain the facts of that offense where he established that he does not limit his violence to peace officers, strangers, and his partner; he expanded his pool of victims to a child in his custody as well. By 2008 he had violated parole.

Inmate Kelley then returned to Sacramento County while on parole and in 2009 was convicted of driving under the influence and he sustained another parole violation. In 2011 he again violated his parole.

Paroled again by 2015 for his assault with a deadly weapon conviction, Inmate Kelley was found loitering in front of a building and was contacted by the police. He admitted to the officer that he had heroin and a fixed blade knife concealed on him. While on parole for assault with a knife, Inmate Kelley once again armed himself with that deadly weapon, and possessed mind altering substances. This combination by a

parolee who assaults women, children, and neighbors and resists officers clearly establishes that he presents a risk to public safety. As such, the District Attorney requests that early release be denied.
