Moreno's felony record extends back to the 1990s. His felony history is as follows:

- 4. 8/25/94 Violation of PC 273.5 Domestic Violence (Sacramento County)
- 5. 6/10/99 Violation of HS 11378 Felony Possession of Narcotics for Sale (Sacramento County);
- 6. 1/31/06 Violation of HS 11378 Felony Possession of Narcotics for Sale and PC 2800.2 Felony Evasion (Sacramento County);
- 7. 7/6/11 Violation of HS 11378 Felony Possession of Narcotics for Sale and PC 12021 Felon in Possession of a Firearm (Sacramento County);
- 8. 6/5/14 Violation of HS 11351 Possession of Narcotics for Sale and HS 11352 Transportation of Narcotics for Sale (Placer County)
- 9. 1991-2014 Almost a dozen Parole Violations

health and safety of whatever county he lives. It cannot be said enough how blatant Moreno's
complete disregard for the laws and safety has been over decades. It is clear that
inmate Moreno should not be released as he poses a significant, unreasonable risk to the
community. Parole should be denied.
