For 20 years, Inmate Reed has had an uninterrupted life of crime, culminating in his current sentence for 3 counts of second degree burglary for his involvement in a retail theft ring.


A brief summary of his record of convictions is as follows:

- 1994 PC 459 burglary misdemeanor
- 1994 H&S 11377 possession of methamphetamine misdemeanor diversion
- 1994 PC 273.6 misdemeanor violating a restraining order
- 1994 PC 273.5 misdemeanor domestic violence
- 1994 PC 273.5 misdemeanor domestic violence [separate case]
- 1994 H&S 11377 felony possession of methamphetamine
- 1994 PC 459 felony burglary
- 1995 H&S 11377 meth possession felony [1996 violation of probation]
- 1996 PC 459 1st degree felony residential burglary: a strike **2 years prison**
- 1997 VC 10851 and VC 2800.2, felonies [vehicle theft and felony evasion] **3 years SP**
 - 1998 parole violation
 - 1999 parole violation
- 1999 VC 23103.5 misdemeanor ['wet reckless']
 - 2000 parole violation
 - 2001 parole violation
- 2001 VC 2800.2 felony evading **32 mos SP**
 - 2003 parole violation

 - 2005 parole violation
- 2005 VC 10851 vehicle theft [**6 years SP re-sentenced to 32 mos SP** in 2007]
 - 2008 parole violation
 - 2009 parole violation
- 2010 H&S 11377 felony meth possession **16 months SP**
- 2011 3 counts PC 459 felony burglary second degree **8 years 8 mos. SP**

He has had 11 felony convictions and 6 prior prison commitments. He knows no other life other than the revolving doors of crime and punishments. He steals people's cars, engages in high speed, dangerous pursuits with officers in order to evade arrest, uses methamphetamine and breaks into people's homes and businesses.

Our Career Criminal unit prosecuted this case. The purpose of the unit is to target high risk, recidivist offenders in order to protect the public for as long as possible. The District Attorney request that Inmate Reed not be given the non-violent second striker discount, as he presents a threat to public safety and security.
