Inmate Young has made a career of victimizing others. He has been a menace to this community since the age of 19 when he began committing misdemeanor burglaries. From 1984 until the present, Inmate Young has committed a vast array of crimes that include: burglary (numerous), grand theft person, petty theft with a prior, narcotics possession, assault with a knife (two separate occasions), check fraud, trespassing, vandalism (numerous), and possession of a knife. Inmate Young has spent a large portion of his adult life in and out of both County Jail and Prison because of his many arrests and subsequent convictions. Inmate Young has proven time and again that he will not change his behavior and become a productive member of society. Make no mistake, Inmate Young will re-offend and continue to victimize members of this community once he is released from prison custody.

The current case, wherein Inmate Young was in possession of a concealed knife, actually stems from a report of several car burglaries and vandalisms. Inmate Young not only matched the description of the person seen breaking into one of the victim vehicles, but he was in possession of a concealed knife that had a metal stud attached to one end, the type that is used to crack windows. While he wasn't charged with the vehicle burglaries, these window smashing break in's match Inmate Young's modus operandi all the way down to the specific part of town that he continually victimizes. Not only has Inmate Young proven himself dangerous with a knife, receiving two strike convictions for separate assaults with a knife, but he is a serial burglar and vandal and has proven a failure and probation and parole.

Although I have not had an opportunity to review his C file in order to determine whether his behavior has conformed to institutional requirements during this most recent incarceration, I would ask the Board to do a serious review of his institutional history. It would be nothing short of miraculous if those records show a sudden turnaround in behavior by a man whose lifelong

history is one of complete disregard for the rules and regulations of a law-abiding society.

Giving Inmate Young the benefit of early release only provides him with more time to victimize more people in the greater Sacramento area. Inmate Young has picked up either a substantive offense or violated his parole in the following years: 1984, 1985, 1991, 1993, 1994, 1996, 1997, 1998, 1999, 2001, 2003, 2005, 2006, 2008, 2011, and 2015. Inmate Young was in and out of prison from 1994 until his discharge in 2000 and again from 2011 until 2013. Inmate Young has earned every bit of custody time he was sentenced to and as such, the Sacramento County District Attorney's Office strongly opposes Inmate Young's early release from state prison.
