## Re: Clark, Danny CDC # AP2181 Court Docket: 16FE009785

Inmate Clark has established himself as a dangerous felon who was on active parole at the time of his most recent conviction. Inmate Clark should not be granted parole. The circumstances surrounding his current conviction and his prior criminal record show that he poses an unreasonable risk of violence to the community.

On May 17, 2016 at approximately 6:18 in the evening, Sacramento Sheriff Gang Detectives were patrolling the area of Edison Avenue and Fulton Avenue, in the county of Sacramento. The Detectives observed a silver two door Lincoln with no record on file with DMV. The vehicle failed to stop at the limit line of the intersection and was missing the right front bumper. A traffic stop was conducted, and inmate Clark was located as the sole occupant in the driver's seat. Inmate Clark told the Detective's that he did not have any identification and that he was on probation. Inmate Clark was not on probation but had been placed on parole on February 7, 2016, following a residential burglary conviction and prison term. A record check of inmate Clark was conducted. Detective **Detective felony** warrant issued for his arrest, a PC 3056 parole warrant.

The detectives conducted a search of inmate Clark. Rolled into the cuff of his pant leg was 15.1 grams of methamphetamine. The methamphetamine was wrapped in plastic that was twisted/knotted at the top and sealed with melting. During the search detectives observed multiple tattoos used by White Power gangs on the inmate's body. Specifically, inmate Clark had a "23" and a "16" tattooed on the back of his head. Inmate Clark told the detectives that the "23" represented the 23<sup>rd</sup> letter of the alphabet, W, and the "16" represented the 16<sup>th</sup> letter of the alphabet, P, standing for White Power. On his abdomen detectives observed tattooed "SWP". Inmate Clark told the detectives this stood for "Supreme White Power". Detectives also observed SS lightning bolts and swastikas tattooed on this inmate's body. Based on his possession of methamphetamine for sales and his gang related tattoos the detectives validated this inmate as an active Supreme White Power gang member.

This inmate has shown through his own actions that if given early release he will remain a threat to the community. During the commission of his strike offense this inmate ransacked the home of

his victim. He stole multiple items including a vehicle from inside the attached garage, damaging the garage door in the process. The inmate's actions cost the victim \$43,982. He lasted barely 3 months on parole for that strike offense before he continued his criminal conduct. Three months out on parole and he was validated as an active gang member and found to be possessing and transporting methamphetamine for the purpose of sales. This inmate has shown a failure to be rehabilitated as he has served 8 prior stints in prison and has continued to re-offend including while on parole.

As we are given 30 days to respond, and we are not provided with any disciplinary history or any other information aside from the one-page notice of parole review, I cannot comment on inmate Clark's prison conduct. However, from the record that is available it is clear that inmate Clark should not be released as he poses a significant, unreasonable risk of violence to the community. He committed this new offense while on parole for his prior strike offense. Parole should be denied.
