**Re: Wolfe, Danielle      CDC # WF1593      Court Docket: 17FE002491**

Inmate Wolfe is a well-established habitual Felon and should not be paroled. The circumstances surrounding her current conviction and her prior criminal record show that she poses an unreasonable risk of significant criminal activity to the community and has not shown any progress toward establishing herself suitable for parole.

On February 7, 2017, at approximately 10:11pm, an officer on patrol observed a white Ford Explorer turning from Oak Avenue Parkway onto northbound Folsom/Auburn Road. The vehicle was noted to make a slow turning motion and proceeded to travel 25 miles per hour in the 50-mile per hour zone. A record check of the license plate showed it was expired as of 1/8/17; however, was displaying an orange 2018 sticker. The vehicle continued to travel at a slow speed and proceeded westbound onto Inwood Drive. The officer conducted an enforcement stop due to the expired registration and the suspicious slow driving.

Officers contacted the driver, [REDACTED] D [REDACTED], and the female passenger who claimed she did not have identification. She verbally identified herself as "[REDACTED] A [REDACTED]"; and provided a date of birth. D [REDACTED] and "A [REDACTED]" denied being on probation or parole. A records check of "A [REDACTED]" revealed no information and when confronted for further information, the defendant advised they try her maiden name; "Wolfe", and provided another birthdate. The officer conducted a record check of D [REDACTED]'s address and located a female name Danielle Wolfe with a date of birth of 2/14/83, who returned on active CDC parole. The officer matched her picture to the female passenger.

A search of the vehicle was conducted, on the passenger side of the floorboard were two purses; a small pink and a large black purse. The defendants denied ownership or possession of the purses. Inside the pink purse was an address from Red Rock Court in Folsom. Inside the black purse, multiple credit cards were found with D [REDACTED]'s name on it. Multiple other credit cards were found that had different subjects' names, checks, driver's license and a list of accounts and bank numbers.

In the glovebox, mail from Loomis and Granite Bay area were found. In the back seat, officers located a large plastic tub with over 70 pieces of mail from the Folsom and Orangevale area. During a further search, the officer also located four different pry bars.

After the defendant was booked, the officer began to go through the apparent stolen mail. One of the addresses the officer recognized and knew the individual had video cameras on their home. The officer obtained video from this resident. The camera showed the defendant holding a black purse, walk up to the individual's mailbox, open it, look inside and close it. Just doors down was another residence that had stolen mail.

The defendant stated in jail, "I pled out. I was not aware of everything that was in the car and can't claim responsibility."

Wolfe was not new to the theft game. She had multiple theft and fraud related convictions as well as a first-degree burglary. On September 5, 2014, the victims returned home to find their home had been burglarized. The victims reported a Toshiba laptop; Samsung Tablet; a cell phone, and credit cards were stolen from the home. Shortly after the break-in, the victims note some of the credit cards were used at a Rite Aid, and through a Pay Pal account on the Discover Card. An attempt to use another credit card at a Walmart had been declined. The victims added their car keys to two of the vehicles, and jewelry was also stolen. It was related the point of entry was a broken window frame. Officers obtained closed-caption footage of the locations where the credit cards were used. The video showed a female adult and a male adult along with a small child in the video footage. The male was subsequently arrested implicated the defendant with the break-in. Upon receiving an identification of the female, the officers showed the victims the video footage and they identified the defendant. They related the defendant was the ex-girlfriend of the victim adult's son. Furthermore, she was the mother of the victim's grandchild. The victims noted the defendant did not have keys to the residence and did not have permission to be in the home.

[REDACTED] she has returned to custody multiple times, having at least five separate state prison commitments. During her time in prison, it does not appear that she has taken advantage of the multiple programs offered to her.

Based upon inmate Wolfe's extensive criminal record, it appears she has not stayed crime free [REDACTED] and has not done much by way of programming during her prison commitment, therefore this should make her an inappropriate candidate for early parole. Wolfe should not be released as she poses a significant, unreasonable risk of significant criminal activity perpetrated on the community. It appears she will likely continue this path of criminality since there has been little attempt to change established criminal behavior. Therefore, parole should be denied.
