Inmate Dorrell Bolton is a career criminal that has engaged in a lifetime of fraud, narcotics trafficking and possession of firearms. Inmate Bolton has consistently demonstrated his propensity to continue to commit crimes of increasing severity and dangerousness. In order to protect the community from continued crimes, the People oppose any early release of Inmate Bolton's agreed upon sentence and one that he justly earned.

In 2003, Inmate Bolton was convicted of trafficking in narcotics. He was sentenced to probation and 270 days in custody. In 2005, Inmate Bolton was prosecuted federally for counterfeit securities and sentenced to 21 months federal prison. Then in 2009, Inmate Bolton was sentenced to 2 years state prison for illegal possession of a firearm. Then in 2010, Inmate Bolton was sentenced to 5 years of custody in the State of Georgia for forgery and possession of marijuana for sales. Then in 2011, Inmate Bolton was sentenced to a year of jail, back in the State of California for illegal possession of a firearm. It is clear that despite continued convictions for firearms, Inmate Bolton continues to reoffend.


Which leads directly to Inmate Bolton's committing offense. On April 25, 2018, agents with the Federal Bureau of Alcohol, Tobacco and Firearms (ATF) executed simultaneous warrants on four of Inmate Bolton's structures including his residence, his office/studio and his storage units. In three of the structures, ATF agents recovered an arsenal of firearms (12 firearms in total). Of these firearms, two were assault weapons, two (found in two of the separate locations) were stolen in a residential burglary in Las Vegas. In addition, Inmate Bolton was found with hundreds of rounds of ammunition and 7 pounds of marijuana that was packaged for distribution.

In addition, while the above case was pending and Inmate Bolton was released on reasonable bail, he stole a vehicle. That charge was ultimately dismissed by the People in light of his plea to the firearms, ammunition and marijuana possession case.

I am unable to comment on Inmate Bolton's disciplinary history while incarcerated as I only have 30 days in which to respond. Inmate Bolton was sentenced on a fraction of the time for which he was guilty. Inmate Bolton should serve the complete and just sentence for which he bargained for, and for a sentence which reflects his continued criminality. As such early parole should be denied.
