

The FJC model brings victim services under one roof. This lessens the trauma for those who have already been victimized. They only have to tell their story one time.

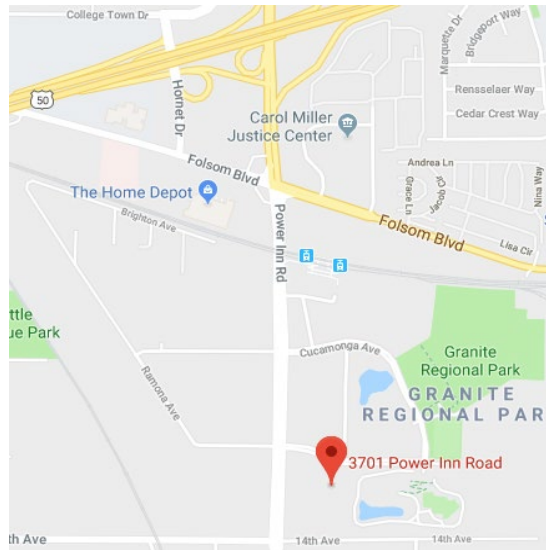
The core concept is to provide one safe place where victims of domestic violence, elder abuse, and those who have been trafficked, can go to talk to an advocate, plan for their safety, apply for a Temporary Restraining Order, meet with law enforcement and prosecutors together, receive trauma informed counseling, social services, spiritual care, and more.

The FJC is highly collaborative – we do not duplicate the excellent work and services of our community partners. We simply help to coordinate, comfort, and bring hope to those who have suffered abuse.

The U.S. Dept. of Justice has identified the Family Justice Center model as a best practice in the field of domestic violence intervention and prevention services.

- ❖ Case Management, Danger Assessments, and Safety Planning
- ❖ Trauma informed peer, group and individual counseling
- ❖ Assistance with Domestic Violence & Elder Abuse Restraining Order Petitions
- ❖ Mobile legal services clinics throughout Sacramento County
- ❖ Child and Family Therapy

Frequently Asked Questions

Who can get help at FJC?

FJC helps survivors of domestic violence, elder and child abuse, sexual assault, stalking and human trafficking.

Do I need an appointment?

No. Individuals requesting a restraining order or who need help with emergency safety planning, shelter, crisis counseling, assistance with prosecution, or other supportive services are seen on a first-come, first-serve basis.

For family law matters, individuals may be seen the same day depending on attorney availability. If an attorney is not available, you can schedule an appointment.

What should I bring?

You should bring legal documents including: existing restraining orders, child custody and visitation orders, and police reports.

Can I bring my children?

Yes, we have a designated area for children. Play care is sometimes available but we recommend that if you can, please bring another adult to watch your children while you receive services.

Can I volunteer or do an Internship at the FJC?

Yes. All volunteers and interns are screened and will go through training.

Do I need to bring an interpreter?

Many of FJC's staff members are bilingual. If needed, we will do our best to arrange an interpreter to assist you.

Community Partners

Such as: law enforcement, SAFE Center, Community Based Organizations, Adult Protection Service, and other partners.
