Inmate Gallardo is a well-established violent felon and should not be paroled. The circumstances surrounding his current conviction and his prior criminal record show that he poses an unreasonable risk of violence to the community.

On September 9th, 2021, officers contacted Inmate Gallardo at a traffic stop. The officer saw a firearm inserted into the steering column in plain view. The firearm was loaded and had been reported as stolen. A search of the vehicle yielded 11.89 grams of marijuana, two electric scales, \$95 in cash, 12.7 grams of heroin and bindles with narcotics.

While pending charges, Inmate Gallardo picked up a new case on September 28th, 2022. On that date, the police were dispatched to a suspicious circumstances call. The caller indicated that the home was vacated but two transients were seen entering the home. Officers walked around the home and located Inmate Gallardo inside. At first, Inmate Gallardo provided his name as a false name. Officers searched his person and found bullets in his front pocket. Officers then proceeded to search the Inmate's car and quickly located a 9mm handgun on the floorboard next to his jacket.

Inmate Gallardo earned his prior strike offenses in 2007 with a robbery conviction. In that case, the victim and Inmate Gallardo were acquaintances. Inmate Gallardo asked the victim for a ride. When the victim agreed and after they got into the car, Inmate Gallardo pulled out a knife and a second subject jumped in with a gun. The second subject told the victim to hand over his property. Inmate Gallardo said, "Just let me cut him". The second subject then hit the victim on the head with the firearm as Inmate Gallardo reached into the victim's pockets and took his wallet, watch, necklace, and an earring.

Inmates Gallardo's criminal conduct does not stop there. Over the past 24 years, the Inmate has sustained nine felony convictions. Eight of those prior felony offenses resulted in state prison commitments. Inmate Gallardo has lived a life of violent crime and will not stop.

As we are given 30 days to respond, and we are not provided with any disciplinary history or any other information aside from the one-page notice of parole review, I cannot comment on inmate Navarro's prison conduct. However, from the record that is available it is clear that inmate Navarro should not be released as he poses a significant, unreasonable risk of violence to the community. Parole should be denied.
